NO WEAPONS ALLOWED

All individuals are prohibited from possessing any and all dangerous weapons on Morton County Fairgrounds property, regardless of the individual possessing a Concealed Weapons License or attempting to exercise North Dakota Constitutional Carry rights. Only on-duty Law Enforcement officials and licensed on-duty security personnel are exempt from this (NDCC 62.1, NDCC 43-30-04, & ND Admin Code 93-02-02-1).

ALCOHOL POLICY

Alcohol consumption by those under the age of 21, providing alcohol to those under the age of 21, and driving under the influence is **PROHIBITED** (NDCC 05-01-08, NDCC 0505-01-09, & NDCC 39-08).

TRAFFIC & PARKING

All individuals on location at the Morton County Fairgrounds must comply with the instructions and/or directions provided for authorized vehicle traffic and parking. Morton County Fair Board personnel or their authorized agents will direct vehicle traffic and parking activities.

Unauthorized vehicles or vehicles found to be in violation of any Morton County Fair Board rules, if not moved when directed to do so, will be towed at the vehicle owner's expense.

DOG POLICY

The Morton County Fair has enacted a no pet's policy in the core area of the fairgrounds. Pets are not allowed in the buildings, barns, concession areas, show arena, track, or rodeo arena.

Pets are allowed in the campground and parking lots only. All pets must have proof of shots, be on a leash and accompanied by owner. Any pets left in vehicles will be reported to the Morton County Sheriff's Department and will be at the owner's expense. Please keep that in mind before you bring your pets to the fair.

Exceptions: Service animals, ADA animals and animals that are on the grounds for exhibition in a 4-H and open class livestock event.

Morton County Fair requires all pet owners to clean up after their pets while on the fair grounds.

UTV POLICY

To reduce the liability and risk to the Morton County Fair Association, the following policy has been put into place. All golf carts, four wheelers and UTV's used by fair patrons is banned. Golf carts, four wheelers and UTV's shall be used for official use only by the fair board (directors and associate members), 4-H, Security, and Parking Attendants. There must be proper signage or permit on the unit, any golf cart, four wheeler or UTV without proper signage or permit displayed will not be allowed on the Morton County Fair Grounds and can be removed by contracted Security, Morton County Fair Association or Law Enforcement.

if an individual needs to use said vehicles due to health issues or mobility issues, they need to ask the Morton County Fair Board for a permit and sign a Release of Liability.

UVA (DRONE) POLICY

The operation or use of any drones, unmanned aircraft/flying systems, and remotely controlled or radio controlled flying machines(whether or not motorized) of all types, shapes, and sizes (collectively "drones") at any time on the Morton County Fairgrounds is prohibited under all circumstances except pursuant to the terms and conditions of written permissions from the Morton County Fair Board. This policy applies to all individuals, persons, companies, and business entities and includes, but not necessary limited to, promoters, tenants, renters, patrons, visitors, and guests. Permissions to stay or remain on the Morton County Fairgrounds property may, in the discretion of the Morton County Fair Board, be revoked for any person(s) in violation of the policy.
