

Camping Rules for Electrical Hook-Up

1. Absolutely NO camping spaces will be used for parking vehicles.
2. Campers must have a valid camping permit clearly displayed at all times.
3. All vehicles used to transport RV's must have a valid auto pass.
4. Campers are defined as a mobile living structure.
5. Any vehicle without a valid pass will be towed at the owner's expense.
6. All camping sites are grass and are NOT on level ground. Additional blocks and leveling products or equipment may be required. Morton County Fair and/or its associates are not responsible for damages caused by incorrect leveling or blocking.
7. Only 2 vehicles allowed per camping site. Parking passes will be mailed with the camping packages.
8. Electrical posts will have 50 amp, 30 amp, or 20 amp spot(s). You reserve the correct amperage needed for your unit. **Using any spot or amperage that you did not reserve is strictly prohibited and will be grounds for removal from property and banned from future rental.**
9. Extra electrical cords may be required to reach the power supply, you must bring your own power cords.
10. Camping package includes 2 adult 3 day wrist bands and 5 nights of camping. Electrical camping is sold as 5 night packages only. No single night electrical camping pricing is available.
11. Load in date is the Wednesday of the week of the fair and load out is Sunday the last day of the fair.
12. Note: Horse Trail "P"- not recommended for rear door access trailers.
13. Each purchased site is reserved. Please look at the picture to identify the post locations and the amperage assigned to that camping site.
14. **ABSOLUTELY NO OPEN FIRES OR FIRE RINGS ALLOWED ON THE FAIRGROUNDS.**
15. **QUIET TIME IS 12:30 to 7:00 a.m.**
16. **CAMPERS ARE RESPONSIBLE FOR PICKING UP THEIR GARBAGE, WE NEED TO KEEP OUR FAIRGROUNDS LOOKING BEAUTIFUL!!**

ANY CAMPER FOUND TO BE IN VIOLATION OF ANY CAMPING OR FAIRGROUND RULES, INCORRECT CAMPING LOCATION OR PEDESTAL OR CONNECTED TO INCORRECT ELECTRICAL AMPERAGE CAN AND WILL BE REMOVED FROM THE PROPERTY AT OWNERS EXPENSE AND BANNED FROM ANY FUTURE CAMPING ON THE MORTON COUNTY FAIRGROUNDS. ANY PERSON CAUGHT RESERVING A SPOT FOR A BANNED PERSON WILL ALSO BE BANNED FROM ANY FUTURE CAMPING SPOTS AND WILL BE REMOVED FROM PREMISES AT OWNERS EXPENSE. A TRESPASS NOTICE WILL BE SERVED BY LAW ENFORCEMENT, SECURITY OR A MORTON COUNTY FAIR BOARD DIRECTOR.
